(54) Title: METHOD TO OBTAIN PROTECTION AGAINST BYSTANDER ALLERGEN

(57) Abstract: The present invention relates to a method to obtain protection against simultaneously a specific allergen and a by-
stander allergen, comprising the administration of a compound comprising an allergen binding domain and a Fc domain, whereby
said bystander allergen is unrelated to the allergen bound by said allergen binding domain.
